
Process-Control Building 3D View 1




Proposed Zone 1 North Elevation




Proposed Zone 2 West Elevation




Proposed Zone 4 West Elevation









Proposed Zone 5 West Elevation




Proposed Zone 6 East Elevation




Proposed Zone 13 West Elevation
